	6.1 Sunshine MX State Series	Airoh Helmets MX Series – JW gave written and verbal update. Roma ran a good round, Junior numbers have stayed up but Senior numbers were down. Yamaha and Airoh Helmet flags were stolen on the Friday night. Track work needed to be done on the corner before the double jump as there were a few accidents there. Possibly need to be looked at the next track inspection. The club had to utilise the drags next door for more camping. No gate fee was charged by the club. Shirts have all been prepaid so there will be no stock leftover. Entries have been extended to Wednesday night as there was only two weeks between the rounds. Major sponsor is happy with the event. Paul Baericke cannot make it to the Tivoli Round so the MPE/Husqvarna bike rides cannot be offered for that round. Feedback email was received and there have been some good suggestions received which we can look at for the 2018 series i.e. increased practice laps and possibly change the moto times. Look at running the Series with some rounds not including all classes i.e. Senior 125 (nos halved at Roma), similarly the Vets and Womens classes.
