### 1. ANNOUNCEMENT:

The North Queensland Clubs listed above, hereafter called the PROMOTER will conduct a Zone Series of four rounds being the **2010 North Queensland Natural Terrain Motocross Series** for Senior riders in Open, Lites, Veteran, Vintage, Trailbike & Women's classes and Junior riders in Junior Lites, Mini Lites, 65cc and 50cc Auto classes. The promotion is on behalf of and the Clubs and these clubs are here after referred to as the Promoters.

### 2. JURISDICTION:

- 2.1. The abovementioned meeting has been authorised by Motorcycling Queensland, who has issued the Motorcycling Australia Permit Numbers as above and is open to holders of current Motorcycling Australia Senior and Junior National, Club and One Meeting Licences. **NB: Juniors must have current JCP Logbook and completed 5 hours of training to be eligible for a One Meeting Licence.** This series is restricted to **full financial members of a Northern Zone Club and be able to produce a membership receipt/card.**
- 2.2. The meeting will be held in accordance with the current Manual of Motorcycle Sport General Competition Rules (GCR's), these Supplementary Regulations, and any Final Instructions approved by Motorcycling Queensland. **BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.**

### 3. ENTRIES:

- 3.1. Entries open forthwith and on time entries close last mail **Tuesday 5 days before each round.** **There will be No Entries on the day – No Exceptions.**
- 3.2. In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the Promoter, if such retention is approved by Motorcycling Queensland.
- 3.3. Only entries received on the official Entry Form with the correct fee will be accepted. No phone, email, fax entries will be accepted. **ENTRIES BY MAIL ONLY** and must be sent to the **Series Race Secretary, PO Box 190 Mareeba Qld 4880, NOT TO PROMOTING CLUBS.** **PLEASE NOTE: ALL RIDERS MUST PROVIDE A VOLUNTEER ON RACE DAY FOR FLAG DUTIES, A LIST OF NAMES WILL BE KEPT AND YOU MAY BE CALLED UPON. NO VOLUNTEER AND YOUR RIDER WILL BE EXCLUDED FROM THE DAYS RACING!!**

### 3.4.

1. **LATE ENTRIES (THOSE RECEIVED AFTER THE TUESDAY 5 DAYS PRIOR TO THE ROUND WILL ONLY BE ACCEPTED IF ACCOMPANIED BY A \$20.00 LATE FEE.** Late entries may not be included in the program. **NB: ENTRIES WILL NOT BE ACCEPTED ON THE DAY**
2. A refund of entry fees will only be made if the Series Race Secretary ( Noela Matthews 40926777 / 0419753200 ) is notified **before** the meeting.  
A \$5.00 administration fee will be deducted from **ALL** refunds.

3. Entries may be restricted to 36 riders in each class on a first received basis. A reserve list will be kept and riders are asked to notify the Series Race Secretary ASAP if withdrawing so Reserve Riders can be notified.
4. Riders seeking **One Meeting Licence** must state on their nomination form that a **One Meeting Licence is required.**

**4. INSURANCE:**

- 4.1. National Personal Accident Scheme provides basic cover for death and permanent disability.
- 4.2. **AMBULANCE INSURANCE** is compulsory for licensees.
- 4.3. **IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE.**

**5. MEDICAL SERVICES: Medical Officers/QAS** will be in attendance from the start of practice until 15 minutes after the last race.

To be eligible for overall series trophies a rider must have completed at least 75% of the series (ie. 3 of 4 rounds)

**10. ENTRIES TO CONSTITUTE A CLASS:**

- 10.1. To constitute a Class, the number of competitors entered and competing in each Class shall be six (6).
- 10.2. Should there be insufficient entries in any Class of Competition, the decision to run or cancel the Class, or to Combine and vary any awards and/or trophies, will be at the discretion of the promoter, subject to MQ approval.

**11. MACHINES AND RIDERS:**

- 11.1. All machines entered must comply with the current GCR's for MOTOCROSS Competition.

- 11.2. Multiple entry of the one Machine in the same Class of Competition is not permitted.
- 11.3. Change of rider or machine (not both) may be permitted if submitted in writing to the Clerk of Course and with the approval of the MA Steward at least ten (10) minutes prior to the start of the event in which the substitution is requested. Substitute rider must be eligible to compete ie already be entered for the meeting and be the correct grade or if not entered substitution must be made at machinery with a new entry form. Substitute machine must have passed machine examination, be eligible for the class and replace a machine that can not be reasonably repaired.
- 12. RIDING NUMBERS:**
- 12.1. Wherever possible, competitors will be allocated their **Registered MX Riding Number**, but the Promoter does reserve the right to allocate numbers at their discretion.
- 12.2. All Number Plates on all Machines **MUST** comply with the GCR's.
- 12.3. Number plate colours will be as per GCR's **12.6.3.2.** age group colours for Junior competitors and GCR's **12.6.3.1** for all other competitors. Note:- **Back numbers are compulsory for all Junior and Senior competitors.** Failure to wear a back number will result in a competitor being stopped from competing, until they comply. Back numbers that correspond to the machine number must be shown at machinery.
- 13. GRID/GATE POSITIONS** All positions for all races will be by peg draw, unless otherwise announced at briefing.
- 14. RIDERS BRIEFING:** A Riders Briefing will be held prior to the commencement of practice and **ALL Competitors MUST attend the Riders Briefing.** Riders Briefing is a NON Smoking Area.
- 15. DRUG AND OR ALCOHOL TESTING:**
- 15.1. All competitors and officials are advised that as part of the MA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Drug Agency.
- 15.2. If any doubts exist over banned substances it is recommended competitors telephone the Drugs in Sport Hotline 1800 020506. When drug testing takes place, the payment of prizemoney may be delayed at MQ's discretion until the results of the tests are known.
- 16. CODE OF CONDUCT:** All Competitors, Officials and Parents are reminded of the Motorcycling Australia By-Law - CODE OF CONDUCT (as stipulated in the GCR's) which is a guide to appropriate behaviour at all Motorcycle Race Meetings. The CODE OF CONDUCT applies to this meeting and will be enforced.

- Depending on numbers some classes may be combined for practice or racing.**  
**NB:** All bikes must go through machinery on Sunday and must comply with GCR's.
- 18. CIRCUIT DESCRIPTION:** Mainly natural terrain with some man made parts, eg; jumps.
- 19. STARTS:** All starts will be by self-penalising gates or rubber band start. A two minute board may be displayed and competitors must be ready to start after the two minutes as per GCR's . After this time a 15/5 second signal will be used with the gate dropping a minimum of 5 seconds after the 5 seconds board is displayed. Starts may not be delayed after the two minutes has expired. All rounds have minimum thirty (36) gates.
- 20. RACING:** There will be a minimum of 5 minutes or 3 laps of practice offered. Race format will be as per paragraph eight (8). Practice is limited to 125% of the grid per group. Some classes can be combined provided the GCR's and the maximum number are not breached.

21. **NOISE:** As per GCRs (be prepared to replace exhaust systems that fail)

**22. SPECIAL NOTES AND WARNINGS:**

- 22.1. The Series Race Secretary will receive from the promoters of each round the amount of \$3.50 per rider for all riders competing.
- 22.2 The age of Junior competitors will be age as at 1<sup>st</sup> January. Competitors may choose to move up an age group after their birthday but can not take any points with them to the higher age group.
- 22.3 Depending on entries the 85cc classes & the Junior Lites classes may be combined but scored separately.
- 22.4. Senior Women & Veteran classes may be combined but scored separately.
- 22.5. Support classes are for novice riders only. These classes may be combined but scored separately. Senior riders who placed 1st-3rd in previous years Natural Terrain series or Closed to Club Series must ride in the Championship class. If required riders may be re-graded prior to racing at the discretion of the Race Secretary in conjunction with the Promoting Clubs. Support riders cannot compete in the Championship classes and Championship riders cannot compete in the support classes.
- 22.5 Nominations are to be sent to the **Series Race Secretary's, PO Box 190 Mareeba Qld 4880** before closing date. Series nominations are encouraged and only one entry form is required, however a separate cheque **MUST** be made out to the respective Promoting club per round. **If nominating rounds individually please send separate nomination forms along with separate cheques made out to the respective promoting clubs.** No nominations will be accepted less than 5 days prior to each round unless accompanied with \$20. Late fee. **NO NOMINATIONS ON THE DAY NO EXCEPTIONS.** Please include a self addressed stamped envelope for return of receipt/confirmation of your nominations.
- 22.6 Presentation: All trophies will be handed out at the presentation at the conclusion of racing. Series trophies will be handed out at the end of the presentation at the final round.
- 22.7 Please note that tear offs are not allowed at any of these events.
- 22.8 Details of meeting results will be posted and updated on the MQ website ([www.mqld.org.au](http://www.mqld.org.au)) within 7 days of the round.

### DEFINITIONS

### ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

#### ACKNOWLEDGE that:

- ) motorcycle sport is dangerous and that by engaging in the sport (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
  - that I may be injured, physically or mentally, and may be killed;
  - that my machinery or equipment may be damaged, lost or destroyed;
  - that competitors may ride dangerously or with a lack of skill;
  - that track or event conditions may be hazardous and may vary without warning or predictability;
  - that organisers, officials, landowners/track operators and any agents or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events;
  - that any policy of insurance of or in respect of my life or physical or mental health may be voided;
  - that there may be no or inadequate facilities for treatment or transport of me if I am injured;
  - that I have an obligation to myself and to others to act safely and within the rules and regulations of MA;
  - the Indemnitees do not make any warranty that the services at the Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
  - to the extent that any warranty is implied it is excluded to the full extent permitted by law;
  - have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Event.

### WARNING UNDER THE FAIR TRADING ACT 1999 (VIC)

Under the provisions of the Fair Trading Act 1999 (Vic) several conditions are implied into contracts for the supply of certain goods and services.

These conditions mean that the supplier named on this form is required to ensure that the recreational services it supplies to you are:

- rendered with due care and skill;
  - as fit for the purpose for which they are commonly bought as it is reasonable to expect in the circumstances; and
  - reasonably fit for any particular purpose or might reasonably be expected to achieve any result you have made known to the supplier.
- Under section 32N of the Fair Trading Act 1999, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form.

**NOTE:** The change to your rights, as set out in this form, does not apply if our death or injury is due to gross negligence on the supplier's part. \*Gross

negligence" is defined in the Fair Trading (Recreational Services) Regulations 2004.

For the purposes of the clause 3, "the Supplier" shall mean and include the Indemnitees.

### 5. INDEMNITY AND RELEASE GIVEN TO ORGANISERS

IN CONSIDERATION of the acceptance of me as a participant in the Meeting:

- a) I AGREE TO INDEMNIFY AND KEEP INDEMNIFIED to the full extent permitted by law the Indemnitees and each of them in the following manner:
  - i) that I participate in the meeting at my sole risk and responsibility;
  - ii) that I accept the Venue as it stands with all or any defects hidden or exposed;
  - iii) that I indemnify and hold harmless the Indemnitees, their respective servants, agents, officials and competitors against any actions, costs, losses or claims which may be made by me or on my behalf for or in respect of or arising out of my death or any injury loss or damage caused to me or my equipment whether caused by negligence, breach of contract or in any other manner whatsoever.
- b) I AGREE TO RELEASE to the full extent permitted by law the Indemnitees and each of them from all liability to me for any claim, loss, damage, cost or expense (whether arising under statute, from negligence, personal injury, psychological trauma, death, property damage or infringement of third party rights or otherwise) that arises as a result of any act, matter or thing done, permitted or omitted to be done by me or which is in any way connected with my presence at or involvement in the Event.
- c) The release and indemnity provided by me in this declaration is in addition to, and will not in any way limit the application of, the conditions of sale attaching to tickets, conditions of entry, conditions of credentials or any other applicable terms or conditions in respect of the Event.
- d) A term of this release and indemnity will not apply where the term contravenes the law of the relevant jurisdiction under which any legal action is legitimately taken however such terms are severable and do not invalidate the remaining terms.

### 6. MEDICAL

I declare that I am and must continue to be medically and physically fit and able to participate in the Meeting. I will immediately notify MA in writing via my SCB of any change to my fitness and ability to participate. I understand and accept the Indemnitees will continue to rely upon this declaration as evidence of my fitness and ability to participate.

I acknowledge and agree that if required, the Indemnitees (or any of them) may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Indemnitees and agree to meet all costs associated with such action. I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.

### 7. PRIVACY

I hereby consent to the collection of my personal information by the Promoter/Event Organiser, MA and the SCB in connection with my involvement at the Event and the use and disclosure of my personal information by Event Organiser, and MA to other agencies and officials associated with the Event for the purposes of conducting and managing the Event. I understand that I may gain access to my personal information held by contacting MA at 147 Montague St, South Melbourne, Victoria, 3205. I understand that if I do not provide the personal information requested above that I may not be permitted to participate in the Event.

### 8. PERSONAL HEALTH INFORMATION

I hereby agree with MA and the SCB that in consideration for my participation in the Event that MA and the SCB may receive, collect, store and use personal health information about me in the manner set out below:

- a) I ACKNOWLEDGE that:
  - i) If I am injured, become ill or die at or following the Event the party listed at Item 8 in Schedule 1 in addition to any hospital at which I am treated (together "my Carers") will have health related information about me in their possession, power and control relating to me which is subject to obligations imposed by the Privacy Act ("my Information") and the Privacy Act is intended to protect my personal information;
  - ii) MA and my SCB wish to collect my Information for purposes that include their risk management programs, evaluating and improving the safety of MA and SCB events and of the Meeting organisers and facility providers of MA / SCB permitted events, and generally to reduce the risks to persons engaged in motorcycle sport; and

- iii) It is reasonable for MA and my SCB to collect, store, use and disclose my Information in accordance with clause 11(a)(i) above and in the manner set out in clause 11(b).

b) IN CONSIDERATION of my acceptance as an entrant in the Meeting I consent and agree that MA and my SCB:

- i) may collect and store any of my Information, including obtain my Information from third parties including my Carers;
- ii) may use any information collected in accordance with this clause for an purpose consistent with creating safer competition in motorcycle sport and events held by or in conjunction with MA, my SCB, or with an MA SCB permit;
- iii) may disclose my Information to third parties provided such disclosure is reasonably intended to be used for the purpose of improving safety at events held by or in conjunction with MA, or with an MA permit provided any such information is held by MA or my SCB in accordance with the MA Privacy Policy.
- c) I irrevocably authorise MA and my SCB and hereby appoint MA and my SCB as my lawful attorneys to collect from my Carers, and I hereby direct my Care to provide to MA or my SCB upon request being made by MA or my SCB, any of my Information including but not limited to any information concerning any incident or event causing or contributing to or resulting from any injury, illness or death to me, the details of any diagnosis and prognosis provided to me by my Carers (or any party with the knowledge of any of my Carers), and any other matter to the knowledge of my Carers that might reasonably be considered to be requested by MA or my SCB for the purpose of improving safety at MA and SCB events.

### 9. POLICIES AND REGULATIONS

- a) I acknowledge, understand and agree that it is a condition of my participation in the Event that I agree to be bound by, and subject to, the rules, regulations and jurisdiction of MA as amended from time to time. Copies of all MA rules, policies and regulations are available by contacting the MA office.
- b) All participants are bound by the MA anti doping policy and thus understand they may be subject to drug testing. Testing conducted by the Australian Sports Anti-Doping Authority (ASADA) is in accordance with the ASADA Act and the National Anti-Doping Scheme. This involves the taking of a sample (any human biological fluid or tissue whether alive or otherwise, or any human breath) for the purpose of detecting the use of a Prohibited Drug or Doping Method. Any participant infringing MA's policy or refusing a drug test may be disqualified or otherwise dealt with in accordance with the terms of the anti-doping policy.

### 10. RIGHT TO USE IMAGE
